RUUTOS INDEPENDENT ASSOCIATE AGREEMENT

I agree that I am bound by the terms and conditions of this application upon me signing this application even though the application is only effective upon acceptance by Ruutos.

I hereby represent, warrant and agree that I am:

- bound by all elements of the Ruutos Code of Ethics and Conduct and pledge to fully adhere to all element of the Ruutos Code of Ethics and not relying upon any representations as to the financial results I might achieve.
- an independent contractor for all purposes, including tax, and I am not an employee, or any kind of representative of Ruutos
- authorised to work in South Africa.

I agree that the Ruutos Code of Ethics and Conduct and other documents issued by Ruutos may be modified in future from time to time at its sole discretion. Collectively, the Rules are each hereby incorporated into this Agreement.

The term on my Associate Agreement will be indefinite, subject to procedures and requirements as Ruutos Company shall determine in its sole and absolute discretion. I may cancel the Agreement at any time by notifying Ruutos Head Office in writing that I wish to do so.

Ruutos Company may terminate my Associate Agreement if it determines I have violated this Agreement (including without limitation the Rules or applicable law). It may suspend or take other action regarding me as an Associate, in its sole and absolute discretion subject only to the limitations explicitly set forth in the Rules.

As a Ruutos Independent Associate:

- a) I commit to abide by the laws not only to the laws in the country that I live in but also any country where I conduct the Ruutos business as an Independent Associate.
- b) I indemnify and hold harmless Ruutos Company from any cost or liability relating to any breach of this Agreement or violation of applicable law. Ruutos may offset against amounts which could otherwise be due to me amounts to cover such indemnity.
- c) I will comply with Ruutos Code of Ethics as an Associate, published in all countries in which I operate my Ruutos Independent Associate business.
- d) Ruutos Company collects certain personal identifiable information about its Associates. It does so to fulfil its obligations under the Associate relationship and to provide its Associates with the product and services requested.
